



## EESW Project Assessment Criteria 2018-19

The aim of the assessment procedure is to provide feedback to the students by indicating the level of achievement under each of the criteria.

Teams are assessed on the following 8 categories and marks are awarded from 1 to 5 as indicated below (with 5 being the highest). An average achievement equates to 3 marks and the two marks either side indicate performance levels above and below average.

<p><b>1</b> Shows little evidence of planning, time and resource management or teamwork.</p> <p><b>3</b> Some evidence of dividing tasks between members in a reasonable manner, demonstrated planning skills and shown evidence of time and resource management.</p> <p><b>5</b> Project has been well managed and the team have clearly allocated roles throughout the project to ensure delivery at all key stages.</p>	<p><b>1</b> Has submitted a barely adequate report.</p> <p><b>3</b> Has submitted a clear report but which lacks precision or contains too much superfluous information.</p> <p><b>5</b> Has submitted a report which is clear and concise, well presented, accurately sets out the process undertaken and includes adequate and relevant information.</p>	<p><b>1</b> Insufficient material which has not effectively presented the problem and its solution.</p> <p><b>3</b> Used reasonably effective material which has communicated the problem and its solution quite well, but requires further development.</p> <p><b>5</b> Has displayed well-presented material including good quality images to show that the solution can fulfil the brief.</p>	<p><b>1</b> Has not effectively presented the problem and its solution with only some team members contributing.</p> <p><b>3</b> Has communicated the problem and its solution quite well, including all team members and answered questions accordingly.</p> <p><b>5</b> Has made a professional presentation which would convince industry to consider their response (with or without further development) and fully answered all questions with a good understanding.</p>

Mae cyflawniad cyfartalog yn gyfystyr â 3 marc ac mae un marc yn fwy neu'n llai na hynny yn dynodi lefelau perfformiad sy'n uwch neu'n llai na'r cyfartaledd.
